

ORDINANCE NO. 09-03-01

**AN ORDINANCE AMENDING SECTION 52.35
OF THE
CITY OF BENTON'S
CODE OF ORDINANCE
TO PROVIDE FOR A CHANGE IN THE
SEWER RATES THAT SHALL BECOME
EFFECTIVE APRIL 1, 2009**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BENTON, KENTUCKY Section 52.35 of the Code of Ordinance of the City of Benton, Kentucky be amended to provide as follows:

(A) There are hereby established from and after April 1, 2009, the following sewer rates and charges for the City's Waste Water collection and treatment system to be paid by the owner or occupant of each residential or commercial establishment connected to or served by the City's waste water collection and treatment center systems, whether inside or outside of the City's corporate limits, same to be computed and billed monthly as follows:

SEWER

PRESENT RATES

RATES EFFECTIVE APRIL 1, 2009

Inside City Limits

\$3.00 minimum (first 1,000 gallons)
\$4.02 per 1,000 gallons thereafter

\$3.50 minimum (first 1,000 gallons)
\$5.00 per \$1,000 gallons thereafter


Outside City Limits

\$4.50 minimum (1st 1,000 gallons)
\$6.03 per 1,000 gallons thereafter

\$6.00 minimum (1st 1,000 gallons)
\$7.50 per 1,000 gallons thereafter

(B) All of the other provisions of Section 52.35 are confirmed and readopted in all respects as if set out verbatim herein, and no other provisions of Section 52.35 shall be changed or modified except to the extent provided for in Sections (A) and (B) above.
