RESOLUTION OF THE BOARD OF DIRECTORS OF THE CAVELAND SANITATION AUTHORITY, INC dba CAVELAND ENVIRONMENTAL AUTHORITY ADJUSTING SEWER SERVICE CHARGES TO USERS OF ITS MUNICIPAL SANITARY SEWER SYSTEM

WHEREAS, Caveland Environmental Authority, (the Authority) is required by the provisions of the Authority's bond documents to maintain specific rate coverage; and

WHEREAS, these provisions have necessitated a rate increase of 5% per year for next three years;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF DIRECTORS OF CAVELAND SANITATION AUTHORITY, INC. dba CAVELAND ENVIRONMENTAL AUTHORITY AS FOLLOWS:

SECTION 1. The Authority's existing sewer rate service charges are hereby adjusted and shall be as follows:


