CITY OF AUGUSTA COMMONWEALTH OF KENTUCKY ORDINANCE # 2008-__O______

AN ORDINANCE AMENDING SECTION 50.20 (C) and 50.20 (D) OF THE CITY OF AUGUSTA CODE OF ORDINANCES RELATING TO RATES AND FEES FOR SEWERAGE USAGE AND WATER SERVICE AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH TO THE EXTENT OF SUCH CONFLICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUGUSTA, KENTUCKY that the following sections of the Code of Ordinances are amended as follows:

§50.20 (C) Sewerage Usage.

- 1. Each additional unmetered unit, residential, (excepting additional units in multiple unit buildings which are owned by the Housing Authority of the City of Augusta)-\$12.57 per month.
- 2. Each additional unmetered unit, commercial, (excepting additional units in multiple unit buildings owned by the Housing Authority of the City of Augusta)—\$12.57 per month.
- Water Metered Sewer Rate 100 % (One Hundred Percent) of the monthly water reading per month per month.

§50.20 (D) Water

- Each additional unmetered unit, residential, (excepting additional units in multiple unit buildings owned by the Housing Authority of the City of Augusta) \$12.57 per month.
- 2. Each additional unmetered unit, commercial, (excepting additional units in multiple unit buildings which are owned by the Housing Authority of the City of Augusta) –\$12.57 per month.

3. (a) Outside city limits – Base Rates:

First 1,000 gallons @ \$15.57- Minimum Bill All Further Usage @ \$3.07 - per additional 1,000 gallons or portion thereof

(b) Inside City Limits - Base Rates:

First 1,000 gallons @ \$12.57 - Minimum Bill All Further Usage @ \$2.57 - per additional 1,000 gallons or portion thereof

- (E) Severability
 - The invalidation of any part of this ordinance shall not affect the validity of any other part hereof.
- (F) Effective Date
 - This ordinance shall be in full force and effect upon its adoption,
 recordation and publication as required by law.
