ORDINANCE 2019-03

AN ORDINANCE FOR ESTABLISHING NEW RATES AND CHARGES FOR THE USE OF AND SERVICES RENDERED BY THE MUNICIPAL WATERWORKS AND SEWER SYSTEM OF THE CITY OF WHITESBURG

This is an Ordinance amending the rates for use of water and sewer services provided by the City of Whitesburg. Be it ordained by the City of Whitesburg that Ordinance 2009-6 is amended as to Section 1 and 5 by this Ordinance to read as follows:

That the rates and charges furnished by the City of Whitesburg, Kentucky are hereby fixed and established on a monthly basis as follows:

Section 1. Monthly Water Rates

A. Minimum Monthly Bill:

The minimum water bill shall be \$13.40 per month inside the City limits and \$24.00 per month per customer outside the City limits, and each water customer shall be entitled to 2000 gallons (or less) of water in each month for such minimum charge.

B. Rates for Water Usage in Addition to Minimum Charge:

Section 5. Water and Sewer Connection Charges and Deposits

The water connection charge shall be for residential customers \$100.00 <u>\$125.00</u> and for commercial customers <u>\$150.00</u> <u>\$1200.00</u>. There will be a <u>\$100.00</u> <u>\$150.00</u> water deposit required for residential customers who rent. There will be a <u>\$250.00</u> <u>\$250.00</u> water deposit required for commercial customers who rent. This deposit will be refundable when the account is paid in full and the service is no longer needed. The server connection charge shall be <u>\$150.00</u> <u>\$150.00</u> for residential customers and <u>\$150.00</u> for

commercial customers; and costs incurred by the City above these connection charges shall be borne by the owner, who shall indemnify the City for such cost.

SEWER RATES

Server rates shall be an additional 115 percent of total water usage.

All Ordinances, Resolutions, Orders and parts thereof, are repealed to the extent of any conflict herewith.

The Ordinance shall become effective July 1 2019, after publication.
