

ORDINANCE #05-04-15

THE CITY OF SEBREE, WEBSTER COUNTY, KENTUCKY, DOES HEREBY ORDAIN;

THAT CHAPTER XV, ARTICLE II, REGARDING WATER RATES AND WATER RATE ADJUSTMENTS; TO ADD SECTION 2-SURCHARGES FOR OUT OF TOWN WATER AND OR SEWER CUSTOMERS AND SECTION 3-FEE FOR FIRE PROTECTION/SPRINKLER SYSTEMS THAT DO NOT HAVE A FLOW METER BUT COULD HAVE A TEST METER.

SECTION 1. THE FOLLOWING RATES SHALL BE CHARGED TO ALL CUSTOMERS FOR WATER SUPPLIED BY THE CITY OF SEBREE. THE FOLLOWING RATES WILL BECOME EFFECTIVE ON THE BILLS THAT WILL BE MAILED OUT ON OR BEFORE MARCH 31, 2015 AND DUE BY APRIL 19, 2015.

OUT OF TOWN CUSTOMERS

5/8, 3/4, AND 1" METERS	\$24.19
1 1/2 & 2" METER AND BUSINESS	\$25.36
METERS LARGER THAN 2"	\$26.53

ALL OVER 2,000 GALLONS WILL BE \$7.54 PER THOUSAND GALLONS.

SECTION 2. OUT OF TOWN WATER AND OR SEWER CUSTOMERS WILL BE CHARGED A \$20.00 SURCHARGE MONTHLY PER EACH DWELLING UNIT. THIS INCLUDES MOBILE HOME PARKS, APARTMENT BUILDINGS, DUPLEXES, ETC. EXAMPE: IF THERE ARE FOUR (4) MOBLIE HOMES ON ONE (1) METER, THERE WOULD BE AN \$80.00 SURCHARGE PER MONTH. THIS SURCHARGE IS IN ADDITION TO THE REGULAR WATER AND OR SEWER BILL.

SECTION 3. THERE WILL BE A \$25.00 FEE PER LINE PER MONTH FOR FIRE PROTECTION/SPRINKLER SYSTEMS THAT DO NOT HAVE A FLOW METER BUT COULD HAVE A TEST METER.

SECTION 4. WITHIN 30 DAYS OF ANY RATE ADJUSTMENT TO PURCHASED WATER COSTS THE CITY WILL INCREASE THE WATER RATE STRUCTURE BY AN EQUAL AMOUNT PER THOUSAND GALLONS. (Added to ordinance 04/07/14).


