

**CITY OF STANTON, KENTUCKY**  
**ORDINANCE NO. 20-009**

**AN ORDINANCE RELATING TO**  
**WATER AND SEWER RATES AND CHARGES**

**WHEREAS**, the City of Stanton is faced with ever increasing operational costs associated with the maintenance of its water and sewer systems and in order to protect the financial stability of the City of Stanton it is deemed necessary and appropriate by the City Council of the City of Stanton to increase the charges for certain services being provided by the City of Stanton;

**NOW BE IT ORDAINED BY THE CITY OF STANTON, KENTUCKY AS FOLLOWS:**

Section 1. The following rates are hereby set and established for water and sewer customers of the City of Stanton:

**(A) WATER RATES**

<b>Gallons used per month</b>	<b>Cost</b>
First 2,000 gallons, (inside city limits)	\$17.60 (Minimum)
First 2,000 gallons, (outside city limits)	\$25.95 (Minimum)
Per additional thousand gallons, (inside city limits)	\$ 5.71 (per thousand gallons)
Per additional thousand gallons, (outside city limits)	\$ 8.33 (per thousand gallons)

**(B) SEWER RATES**

<b>Gallons used per month</b>	<b>Cost</b>
First 2,000 gallons, (inside city limits)	\$23.41 (Minimum)
First 2,000 gallons, (outside city limits)	\$26.10 (Minimum)
Per additional thousand gallons, (inside city limits)	\$ 8.66 (per thousand gallons)
Per additional thousand gallons, (outside city limits)	\$ 9.62 (per thousand gallons)

Water meters shall be read to the nearest 1,000 gallons and invoices for water and sewer service shall be computed to the nearest 1,000 gallons.

(C) Hookup Fees.

Water. Water - \$ 950.00 (3/4 inch line)  
Water - \$1,050.00 (1 inch line)  
Water - cost to city (1 ½ inch line)  
Water - cost to city (2 inch line)

Sewer. Sewer - \$ 950.00 (4 inch line)  
Sewer - \$1,050.00 (6 inch line)  
Sewer - \$1,250.00 (8 inch line)

All hookups will be required to pay a \$25 inspection fee.

In addition to the above charge, each multi-family housing complex shall be responsible for the above fee, as well as \$25 per each unit in the complex

(D) Service call - If the problem is not the city's - \$20.00.

(E) Re-connect fee - \$40.00.


(F) Water/Sewage/Garbage Security Deposit - Any customer receiving water, sewer or garbage services from the City of Stanton will be required to pay a security deposit to the City. Any customer receiving water service shall pay a \$100.00 security deposit. Any customer receiving both water and sewer service shall pay a \$200.00 security deposit.

(G) In the event that the City of Stanton needs to do a road bore in order to connect service, there shall be a fee in the amount of \$400.00.

Section 2. This Ordinance replaces Stanton City Ordinance 17-009 which is hereby repealed upon passage of the present Ordinance.


Section 3. This Ordinance shall take effect after its passage and upon publication. The rates set forth above shall become effective for billing purposes beginning January 1, 2021.
