

ORDINANCE NO. 9-2017

AN ORDINANCE OF THE CITY OF GREENUP, KENTUCKY, AMENDING ORDINANCE NO. 2-1993 PROVIDING THAT OUT-OF-CITY SEWER USERS SHALL PAY A RATE OF \$11.50 PER ONE THOUSAND GALLONS (1,000) OF WATER USED AND A MINIMUM BILL SHALL BE THE USAGE OF TWO THOUSAND GALLONS (2,000) OF WATER PER MONTH.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Greenup,

Kentucky as follows:


SECTION 1: Ordinance No. 2-1993, Article IV, Section 1, is hereby amended as follows:

In-city customers shall be billed at a flat rate of \$5.50 per one thousand (1,000) gallons used, and customers outside the City of Greenup, Kentucky shall be billed ~~\$7.50~~ \$11.50 for every one thousand (1,000) gallons of water used. The minimum bill for in-city service shall be based on two thousand (2,000) gallons of water minimum usage and for outside the City.

SECTION 2: That all Ordinances in conflict herewith are specifically hereby repealed to the extent of said conflict only.

SECTION 3: That each section and each sentence of this Ordinance is enacted separately and the invalidity and/or unconstitutionality of any one particular sentence and/or section shall not affect the validity and/or constitutionality of any other sentence and/or section.

SECTION 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication according to law






