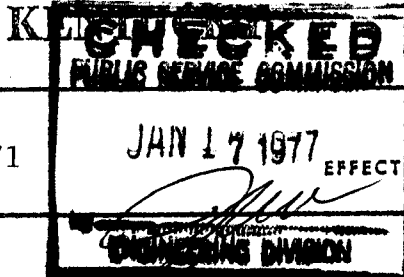

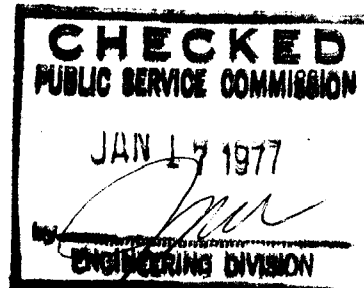

**RULES AND REGULATIONS**

The following rules and regulations are subject to change by the company at any time, subject to the approval of the Public Service Commission.

1. System shall be used for household waste disposal only, and no ground water or overflow pipes shall be connected thereto.
2. No towels, cloth, or other items not susceptible to destruction by aeration shall be introduced into the system.
3. The company shall reserve the right to specify the types of household detergents which may be deposited in the system in the event of future inability of the system to adequately handle non-biodegradable detergents.
4. The system shall not be used for disposal of toxic materials other than normal household products.
5. No materials harmful to the system or to the ecology shall be introduced into the system unless the same can be properly disposed of without harm by proper operation of the system.
6. There shall be a penalty of \$5.00 on any bill not paid within 30 days of the period for which it is due.

In the event any bill remains unpaid for a period of 90 days, the company shall have the right to disconnect the service of the user, for which the user shall pay a reconnection charge equal to the actual cost to the company of said disconnection and reconnection, not to exceed \$100.
