

**CITY OF SACRAMENTO**  
**ORDINANCE NO. 03; Series 2009**

AN ORDINANCE OF THE CITY OF SACRAMENTO, KENTUCKY, INCREASING WATER AND SEWER RATES FOR THE CITY AND WATER DISTRICT; AND ESTABLISHING TAP ON FEES FOR GRAVITY SEWER AND NEW WATER SERVICE; REPEALING ANY CONFLICTING ORDINANCES; AND PROVIDING FOR EFFECTIVE DATES

**BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF SACRAMENTO, KENTUCKY AS FOLLOWS TO-WIT:**

**SECTION ONE:** That ordinance No. 03, Series 2009, An ordinance of the City Sacramento, Kentucky, increasing water and sewer rates for the City and Water District is hereby amended to read as follows:

(A) That the rates for water service for **all residential water customers located inside the City limits** of the City of Sacramento, Kentucky are hereby established as follows:

Residential Inside City Limits	
FIRST 2,000 GAL	<u>27.22</u> <del>25.61</del>
NEXT 4,000 GAL	<u>8.35</u> <del>7.65</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>8.86</u> <del>8.15</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>9.37</u> <del>8.65</del> PER 1,000 GAL
OVER 10,000 GAL	<u>9.88</u> <del>9.15</del> PER 1,000 GAL

(B) That the rates for water service for **all other water customers located inside the City limits** of the City of Sacramento, Kentucky are hereby established as follows:

All Other Customers Inside City Limits	
FIRST 2,000 GAL	<u>35.64</u> <del>33.86</del>
NEXT 4,000 GAL	<u>8.35</u> <del>7.65</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>8.86</u> <del>8.15</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>9.37</u> <del>8.65</del> PER 1,000 GAL
OVER 10,000 GAL	<u>9.88</u> <del>9.15</del> PER 1,000 GAL

(C) That the rates for water service for **all residential water customers located outside the City limits** of the City of Sacramento, Kentucky are hereby established as follows:

Residential Outside City Limits	
FIRST 2,000 GAL	<u>38.17</u> <del>36.34</del>
NEXT 4,000 GAL	<u>8.35</u> <del>7.65</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>8.86</u> <del>8.15</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>9.37</u> <del>8.65</del> PER 1,000 GAL
OVER 10,000 GAL	<u>9.88</u> <del>9.15</del> PER 1,000 GAL

(D) That the rates for water service for **all other water customers located outside** the City limits of the City of Sacramento, Kentucky are hereby established as follows:

All Other Customers Outside City Limits	
FIRST 2,000 GAL	<u>47.45</u> <del>45.44</del>
NEXT 4,000 GAL	<u>8.35</u> <del>7.65</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>8.86</u> <del>8.15</del> PER 1,000 GAL
NEXT 2,000 GAL	<u>9.37</u> <del>8.65</del> PER 1,000 GAL
OVER 10,000 GAL	<u>9.88</u> <del>9.15</del> PER 1,000 GAL

(E) The above stated charges and rates shall become effective July 1, 2021 ~~November 1, 2020~~ with said new rates appearing on the next billing cycle commencing with that date.

Effective July 1, 2021 and occurring annually on July 1 of each year thereafter, there shall be a 2% increase on both the flat rate and each 1,000 gallon breakdown increment as listed herein.

(F) The cost for a new water tap-on fee shall be \$300.00.

**SECTION TWO:**

That the rates for sewer services located inside City limits shall consist of a charge of \$23.84 ~~23.60~~ per user for the first 2,000 gallons, plus a sewer treatment fee of \$6.57 ~~6.50~~ for each additional 1,000 gallons treated.

That the rates for sewer services located outside City limits shall consist of a charge of \$25.91 ~~25.65~~ per user for the first 2,000 gallons, plus a sewer treatment fee of \$6.57 ~~6.50~~ for each additional 1,000 gallons treated.

The cost of a new tap-on to the gravity sewer shall be \$500.00.

Effective July 1, 2021 and occurring annually on July 1 of each year thereafter, there shall be a 1% increase on both the flat rate and each additional 1,000 gallons treated rate as listed herein.

**SECTION THREE:**

That all Ordinances or parts of Ordinances in conflict herewith are to such conflict hereby expressly repealed.

**SECTION FOUR:**

If any clause, sentence, part or paragraph of the Ordinance is invalid, such invalidity shall not affect the remaining portions.

**SECTION FIVE:**

This Ordinance shall be in full force and effect on and after its adoption, approval, and publication as required by law.


